INTERNATIONAL ARREST WARRANT AND ORDER FOR SURRENDER

To all States and to the Multinational Military Implementation Force (IFOR)

THE TRIAL CHAMBER OF THE INTERNATIONAL CRIMINAL TRIBUNAL FOR THE FORMER YUGOSLAVIA,

NOTING United Nations Security Council resolution 827 of 25 May 1993, Article 29 of the Statute of the International Tribunal ("the Statute"), as well as Rules 54 to 61 of its Rules of Procedure and Evidence ("the Rules"),

NOTING the indictment submitted by the Prosecutor of the International Tribunal against Ivica RAJIĆ, also known as Victor ANDRIĆ, as reviewed and confirmed on 29 August 1995 by Judge Rustam S. Sidhwa, a Judge of the Tribunal, copies of which documents are annexed to this warrant of arrest,

NOTING the decision of the Trial Chamber of 13 September 1996, reconfirming the indictment following the failure to execute the initial warrant of arrest issued against Ivica RAJIĆ, also known as Victor ANDRIĆ, a copy of which is annexed to this warrant of arrest,

HEREBY DIRECTS the authorities and all officers and agents of all States and requests the multinational military Implementation Force (IFOR) to act promptly with all due diligence to secure the arrest, detention and transfer to the International Tribunal of:

Ivica RAJIĆ, also known as Victor ANDRIĆ, born 5 May 1958 in Jehovac, Kiseljak Municipality, Republic of Bosnia and Herzegovina, now believed to be in Kiseljak (Bosnia and Herzegovina) or in Split (Croatia)

ALLEGED to have committed at Stupni Do (Bosnia and Herzegovina) on or about 23 October 1993, the following crimes:

Grave Breaches of the Geneva Conventions of 1949 and Violations of the Laws and Customs of War,

within the competence of the International Tribunal by virtue of Articles 2 and 3 of the Statute,

AND to advise the said Ivica RAJIĆ, also known as Victor ANDRIĆ, at the time of his arrest, and in a language he understands, of his rights as set forth in Article 21 of the Statute and, mutatis mutandis, in Rules 42 and 43 of the Rules which are set out below, including his right to

remain silent and to be cautioned that any statements he makes shall be recorded and may be used in evidence. The indictment, review of the indictment and decision of this Trial Chamber taken in accordance with Rule 61 of the Rules (the documents annexed to this warrant) must also be brought to the attention of the accused in a language he understands,

AND FURTHER ORDERS the authorities of all States, and the multinational military Implementation Force (IFOR) upon the arrest of the accused Ivica RAJIĆ, also known as Victor ANDRIĆ, promptly to notify the Registrar of the International Tribunal.
