# DRAŽEN ERDEMOVIĆ

### ORDER FOR DETENTION ON REMAND

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("International Tribunal");

CONSIDERING the indictment against DRAŽEN ERDEMOVIĆ ("the accused") submitted by the Prosecutor and confirmed on 29 May 1996 by Judge Sidhwa;

**CONSIDERING** the transfer of the accused to the Tribunal on 30 March 1996, pursuant to an Order of Judge Riad;

**CONSIDERING FURTHER** the initial appearance of the accused on 31 March 1996 before Trial Chamber I, at which he pled guilty to one count of crimes against humanity;

**NOTING** the Sentencing Judgment of Trial Chamber I, rendered on 29 November 1996, (Official Record at Registry Page ("RP") D1 - D58/472bis) which sentenced the accused to ten years imprisonment;

**NOTING FURTHER** the Judgment of the Appeals Chamber of 7 October 1997 (RP A246 - A441) which rejected the appeal against sentence of the accused and found that the initial plea entered by him was not informed and the case should thus be remitted to a Trial Chamber other than Trial Chamber I so that he can replead;

**CONSIDERING** that it is necessary to retain the accused at the United Nations Detention Unit until such time as the case is finally disposed of;

### **PURSUANT TO RULE 54,**

**HEREBY ORDERS** the continued detention on remand of DRAŽEN ERDEMOVIĆ and enjoins the Commanding Officer of the United Nations Detention Unit in The Hague to detain the accused until further order.
