NOTING the Motion For Joinder Of Accused And Concurrent Presentation Of Evidence ("Motion") filed by the Office of the Prosecutor ("Prosecution") on 22 April 1998,

NOTING the Order Of The President on Applications To Assign A Case To A Trial Chamber issued on 21 April 1998 providing that the issues raised in the Motion be discussed by the Prosecution and the Defence for Miroslav Kvočka, Mladen Radić, Zoran Žigić and Milan Kovačević before Trial Chamber II as part of the pre-trial proceedings in the case of *Prosecutor v.
