THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("International Tribunal");

RECALLING its decision of 16 July 1998 to re-open these proceedings and set aside the week commencing 31 August 1998 to hear this matter (Official Record at Registry Page ('RP') D1668 - D1675);

HEREBY

ORDERS that:

- The re-opening of these proceedings shall commence on 14 September 1998 and the sitting hours of the Trial Chamber shall be from 0900 to 1200 hours and from 1330 to 1630 hours;
- 2. The Rules of Procedure and Evidence of the International Tribunal, as amended on 9 and 10 July 1998, shall apply to these proceedings;
- 3. The Defence shall:
- (a) notify the Prosecution and the Trial Chamber by 17 August 1998 of the names of the Prosecution witnesses which it wishes to have recalled;
- (b) notify the Prosecution and the Trial Chamber by 21 August 1998 of the names of Defence witnesses which it intends to recall and any other witnesses which it intends to call;
- (c) file by 21 August 1998 the statements of any new witnesses which it intends to call;
- (d) where relevant, notify the Prosecution and the Trial Chamber by 4 September 1998 of the names of any witnesses which it intends to call in rejoinder;
- (e) file by 4 September 1998 the statements of any witnesses which it intends to call in rejoinder:

4. The Prosecution shall:

(a) take the necessary steps to have those Prosecution witnesses which the Defence wish

to have re-called appear before the Trial Chamber on 14 September 1998;

(b) where relevant, notify the Defence and the Trial Chamber by 28 August 1998 of the

names of any witnesses which it intends to call in rebuttal;

(c) file by 28 August 1998 the statements of any witnesses which it intends to call in

rebuttal;

5. All documents filed by the parties pursuant to this order are to be copied to the Trial

Chamber for the sole purposes of clarifying the issues and properly managing the

proceedings, and shall not be considered as evidence unless and until admitted by the

Trial Chamber as such.
