THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of the Former Yugoslavia since 1991 ("International Tribunal"),

NOTING the "Prosecutor's Request to Set the Prosecutor's 24 July 1998 Application for an Order to the Republic of Croatia for Hearing on 8 January 1999" filed by the Office of the Prosecutor ("Prosecution") on 18 December 1998 ("the Request for Hearing on the 24 July Application") and the "Response of the Republic of Croatia" filed on 5 January 1999, confirming that it is able to attend a hearing on this matter on 8 January 1999,

NOTING ALSO the "Prosecutor's Request for Hearing on Hunton & Williams' Legal Representation of both the Government of the Republic of Croatia and the accused Dario Kordic" filed by the Prosecution on 18 December 1998 ("the Request for Hearing on representation") and the "Response of the Republic of Croatia" and the "Defense Response" to the Request for Hearing on representation, both filed on 5 January 1999, and both seeking the opportunity to submit written briefs on this issue should the Trial Chamber wish to consider taking any action other than obtaining, on the record, statements by the Republic of Croatia and by the accused Dario Kordić that each has been advised of and has consented to the dual representation,

NOTING FURTHER that the "Prosecutor's Motion for amended Protective Order and Measures to protect Victims and Witnesses" filed on 9 October 1998 is also fully briefed by the parties and ready for hearing,

HEREBY ORDERS AS FOLLOWS:

- (1) the Trial Chamber shall hear oral argument on the "Prosecutor's Motion for amended Protective Order and Measures to protect Victims and Witnesses" in closed session on Friday 8 January 1999, commencing at 10 a.m;
- the Trial Chamber shall hear oral argument on the Prosecution's "Application for an Order to the Republic of Croatia for the Production of Documents" in closed session commencing at 2.30 p.m. on Friday 8 January 1999; and

(3) a closed session status conference shall be held on Friday 8 January 1999 at a time to be determined.
