**CONSIDERING** the need to ensure a fair and expeditious trial pursuant to Article 20, paragraph 1, of the Statute of the International Tribunal ("Statute"),

**PURSUANT** to Article 20, paragraph 1 of the Statute and Rule 54 of the Rules of Procedure and Evidence of the International Tribunal,

**HEREBY** grants the Motion and orders the prosecution to file and serve an amended indictment in accordance with the Decision on or before 23 April 1999.
