TRIAL CHAMBER I of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991,

CONSIDERING the Request of the Republic of Croatia filed on 20 November 1998 (hereinafter "Croatia) that the date of the hearing scheduled for 26 November 1998 be changed (hereinafter "the Request"),

CONSIDERING the Order for a witness to appear issued by the Trial Chamber on 5 November 1998.

CONSIDERING the further Order for a witness to appear issued by the Trial Chamber on 25 November 1998,

CONSIDERING the second further Order for a witness to appear issued by the Trial Chamber on 12 March 1999,

CONSIDERING the hearing of 19 March 1999 during which Major Stepan Udiljak, assisted by Mr. Marin Ivanović, appeared with a representative of the Republic of Croatia,

PURSUANT to Article 29 of the Statute of the Tribunal and Rule 54 of the Rules of Procedure and Evidence,

NOTING that the Trial Chamber informed Major Stepan Udiljak that he should appear again before it to present more precisely the responses and arguments of his Government further to the orders for the production of documents issued by the Trial Chamber on 30 January 1998 and 21 July 1998; that Counsel for Croatia informed the Trial Chamber that the hearing might be held on 15 and 16 April, dates which, as the case stands, the Trial Chamber considers convenient,

FOR THE FOREGOING REASONS.

ORDERS that an ex parte hearing be held on 15 April at 14.30 hours to allow the

appearance of Major Stepan Udiljak (hereinafter "the Witness") before the Trial Chamber

with the Prosecutor present,

STATES that a qualified representative of the Republic of Croatia may be present at the

hearing and, under the supervision of the Trial Chamber, may take the floor and STATES

that the Witness may be assisted in the courtroom by Mr. Marin Ivanović,

STATES that, at the request of the Prosecutor, the representative of Croatia or the Witness,

the hearing may be closed to the public and **STATES** that the Witness or the representative

of Croatia may request that the Trial Chamber conduct the proceedings without the

Prosecutor being present,

STATES that, if necessary, the hearing will continue on 16 April 1999,

REQUESTS that the Registrar transmit a copy of this Order to the Embassy of the Republic

of Croatia in The Netherlands and to any authority which may permit or facilitate the arrival

in The Hague of Major Udiljak, his assistant and the representative of the Republic of

Croatia, should that be necessary.
