I, MOHAMED BENNOUNA, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia Since 1991 (“the International Tribunal”),

HAVING BEEN APPOINTED as pre-trial Judge in this matter by virtue of an order of the Trial Chamber dated 3 February 2000,

NOTING the Submission of Amended Attachment to the Amended Indictment (“the Amended Attachment”) filed by the Office of the Prosecutor (“the Prosecution”) on 9 March 2000,

NOTING the Order on Motions for protective measures for witnesses issued by the Trial Chamber on 10 March 2000 (“the 10 March Order”),

NOTING the Motion for protective measures filed by the Prosecution on 24 March 2000,

CONSIDERING the status conference which took place on 28 March 2000 pursuant to Rules 65 *bis* and 65 *ter* of the Rules of Procedure and Evidence of the International Tribunal (“the Rules”),

CONSIDERING the responsibility of the pre-trial Judge to ensure expeditious preparation for trial pursuant to Rules 65 *bis* and 65 *ter* of the Rules of Procedure and Evidence of the International Tribunal (“the Rules”),

HAVING HEARD the parties with regard to matters arising from Rules 65 *ter*(E), 66(A), and 75 of the Rules at the status conference,


PURSUANT TO Rules 54, 65 *bis*, 65 *ter*, and 66 of the Rules,

HEREBY ORDER as follows:

- (1) (a) The Defence for the accused Damir Došen and the Defence for the accused Dragan Kolundžija shall file written submissions on the Amended Attachment by Tuesday 11 April 2000;
(b) The Prosecution shall file any response by Tuesday 18 April 2000;
- (2) (a) The Defence for the accused Damir Došen and the Defence for the accused Dragan Kolundžija shall file their response to the Motion for protective measures with the pre-trial Judge by Friday 14 April 2000;
(b) The Prosecution shall file with the pre-trial Judge a copy of the two witness statements sought to be redacted, together with the proposed redactions, within the same time-limit;
- (3) (a) The Prosecution shall provide the pre-trial Judge with a list of the witness statements to be disclosed to the Defence pursuant to Rule 66(A)(ii), including a list of the statements sought to be redacted, if any, pursuant to the 10 March Order, by Tuesday 11 April 2000;
(b) The Prosecution shall file with the pre-trial Judge the redactions it seeks together with the relevant statements as soon as possible and at the latest by 28 April 2000;
(c) The Prosecution shall disclose to the Defence, pursuant to Rule 66(A)(ii), all witness statements, both unredacted and redacted, as provided to the pre-trial Judge, by Friday 28 April 2000;
- (4) (a) The Prosecution shall file its pre-trial Brief by Tuesday 11 April 2000;
(b) The Prosecution shall file its list of witnesses and list of exhibits by Friday 28 April 2000;
- (5) The Defence for both accused and the Prosecution are directed to meet to discuss the issue of admissions by the parties and of points of agreement and disagreement on matters of fact and law within six weeks of the date of this Order, and to report in writing to the pre-trial Judge thereafter;

AND SCHEDULE a status conference to be held on Wednesday 7 June 2000 commencing at 3.00 p.m., at which both accused and their counsel are to be present.
