I, Claude Jorda, President of the International Criminal Tribunal for the former Yugoslavia (hereinafter "the Tribunal");

NOTING the sentencing Judgement pronounced by the Appeals Chamber on 24 March 2000 in the case IT-95-14/1, *The Prosecutor v. Zlatko Aleksovski*, in which Zlatko Aleksovski, born on 8 January 1960, was sentenced to seven (7) years' imprisonment;

NOTING that the said Judgement states that Zlatko Aleksovski must serve a term of imprisonment ending no earlier than 18 April 2004 except under exceptional circumstances;

PURSUANT to Article 27 of the Statute of the Tribunal, Sub-rule 103(A) of the Rules of Procedure and Evidence (hereinafter "the Rules") and paragraphs 4 to 6 of the Practice Direction on the Procedure for the Tribunal's Designation of the State in which a Convicted person is to serve his/her Sentence of Imprisonment (hereinafter "the Practice Direction");

CONSIDERING the Agreement between the Government of Finland and the United Nations regarding the enforcement of sentences passed by the Tribunal signed on 7 May 1997;

CONSIDERING that the Government of Finland has indicated to the Registry its willingness to enforce the sentence of Zlatko Aleksovski;

HAVING CONSIDERED all the factors mentioned in the Practice Direction, in particular the place of residence of Zlatko Aleksovski's family;

HAVING CONSULTED the Judges of the Appeals Chamber;
