I, PATRICIA M. WALD, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("International Tribunal"),

HAVING BEEN APPOINTED as pre-appeal Judge in this matter by virtue of an order of the Appeals Chamber dated 14 March 2001;

NOTING the Notices of Appeal filed by Zoran Kupreškić, Mirjan Kupreškić, Drago Josipović, Vladimir Šantić, Vlatko Kupreškić, the Prosecution and the briefs and supplemental documents subsequently filed by the parties;

NOTING the Scheduling Order dated 30 May 2001, in which the Appeals Chamber ordered, *inter alia*, that briefs and supplemental documents should be filed publicly with any material requiring confidential treatment discussed in confidential annexes to the filing;
