# SCHEDULING ORDER FOR JOINT HEARING ON THE PROSECUTION'S MOTION FOR JOINDER AND JOINT STATUS CONFERENCE

<u>Counsel for the Accused:</u> Mr. David Eugene Wilson **THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("International Tribunal"),

**BEING SEISED** of the "Prosecution's Motion for Joinder" filed by the Office of the Prosecutor ("Prosecution") on 11 September 2001 in the case of *Prosecutor v. Dragan Obrenović* (IT-01-43-PT), *Prosecutor v. Dragan Jokić* (IT-01-44-PT) and *Prosecutor v. Vidoje Blagojević* (IT-98-33/1-PT) ("Motion");

**NOTING** the responses to the Motion filed by counsel for Dragan Obrenović on 2 October and 5 November 2001, Dragan Jokić on 2 November 2001 and Vidoje Blagojević on 5 November 2001, and the reply of the Prosecution filed on 16 November 2001;

**CONSIDERING** that oral argument from the parties to the Motion at a joint hearing would assist the Trial Chamber in its determination of the Motion;

**NOTING** Rule 65 *bis* (Status Conferences) of the Rules of Procedure and Evidence of the International Tribunal ("Rules");

**CONSIDERING** that the last status conference for the accused Dragan Obrenović was held on 19 October 2001;

**CONSIDERING** that it is in the interests of justice to hold a joint status conference for the accused Dragan Obrenović, Dragan Jokić and Vidoje Blagojević;

**PURSUANT TO** Rule 54 and 65 *bis* of the Rules;

### **HEREBY ORDERS:**

- 1. Oral argument on the Motion shall be held on Tuesday 15 January 2002 at 09.30 hours.
- A joint status conference shall be held thereafter for the accused Dragan Obrenović, Dragan Jokić and Vidoje Blagojević.
