NOTING the “Decision on Appellants Requests for an Extension of Time”, rendered on 1 February 2002, in which all Appellants were granted an extension to file their Appellants Brief until 15 April 2002;

NOTING the “Kos’ Brief on Appeal – From Trial Judgement Dated 2 November 2001”, filed on 2 April 2002;

NOTING the “Second Motion to Extend Time for Filling [sic] Appellant’s Brief – Defence for the Accused Zoran Žigić” filed on 9 April 2002, (“Application”) in which Zoran Žigić seeks a further extension of time for the filing of his Appellant brief;

CONSIDERING that the Conference and Language Services Section has advised the Appeals Chamber that the Judgment will be rendered in the BSC language on 15 April 2002;


