**TRIAL CHAMBER II** ("the Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("the Tribunal");

**NOTING** the "Defence Motion for Provisional Release" ("the Motion") of Accused Mile Mrkšić ("the Accused") on 23 May 2002 requesting provisional release from detention on humanitarian grounds relating to his health, subject to certain terms and conditions set out in the Motion;

**NOTING** the "Order on Mile Mrkšić's Motion of Provisional Release" dated 31 May 2002 instructing the Head of the United Nations Detention Unit ("the Unit") to file a report on the current medical treatment, conditions and facilities, including any special dietary needs being provided to the Accused;

**NOTING** the "Order on Mile Mrkšić's Motion of Provisional Release" dated 31 May 2002 ordering a medical examination of the Accused by experts identified by the Registry;

**NOTING** the Report dated 03 June 2002 filed by the Medical Officer of the Unit on the health condition of the Accused;

**NOTING** the "Urgent Request for Hearing on Motion for Provisional Release" filed by the Accused on 30 May 2002, for hearing two expert witness doctors who participated in his rehabilitation;

**NOTING** the "Prosecution's Response to Motion for Provisional Release Filed by the Accused Mile Mrkšić" to the Motion filed on 05 June 2002 objecting to the Motion;

**NOTING** the "Guarantee of the Federal Government of the Federal Republic of Yugoslavia and the Government of the Republic of Serbia" dated 13 June 2002, for the return of the Accused to the Tribunal if provisionally released by the Tribunal;

**NOTING** the "Additional Defence Submission to Defence Motion for Provisional Release" filed on 27 June 2002 to schedule a hearing on the Motion;

**CONSIDERING** that the medical report requested by Order dated 31 May 2002 has not yet arrived, but will be filed in due course;

**CONSIDERING** that the Chamber is of the view that it is appropriate, prior to considering whether there are sufficient grounds to take a decision pursuant to Rule 65 of the Rules of Procedure and

Evidence ("Rules") to organise a hearing on the Motion, thereby allowing all parties involved to make their oral submissions on the Motion and on the conclusions of the Medical Reports;

PURSUANT TO Rule 54 of the Rules;
