BEING SEIZED OF the "Motion to Determine Issues as Agreed between the Parties and the Trial Chamber as Being Fundamental to the Resolution of the Accused's Status before the Tribunal in Respect of the Jurisdiction of the Tribunal under Rule 72 and Generally, the Nature of the Relationship between the OTP and SFOR and the Consequences of any Illegal Conduct Material to the Accused, his Arrest and Subsequent Detention" ("Motion"), filed by the Accused Nikolić on 29 October 2001;

NOTING the "Prosecutor's Response to Defence "Motion to Determine Issues as Agreed between the Parties and the Trial Chamber ... and the Consequences of any Illegal Conduct Material to the Accused, his Arrest and Subsequent Detention", filed 29 October 2001" ("Response"), filed by the Prosecution on 12 November 2001;

NOTING the Agreement between parties, reached after the Status Conference of 29 August 2001, on the legal issues that needs to be resolved first before a further hearing may be held to determine the factual circumstances of the Accused's arrest;

NOTING that the "assumed facts" on which the legal arguments of parties were to be based were the portions of the Accused's statement to the OTP as to the circumstances of his arrest;

NOTING that the Trial Chamber has never received copies of these portions of the Accused's statement;

CONSIDERING that access for the Trial Chamber to these portions is of crucial importance to decide upon the Motion;
