HAVING BEEN APPOINTED as pre-trial Judge in this case by virtue of the order of Trial Chamber III dated 10 December 2001,

NOTING that a Status Conference has been scheduled for Monday 29 July 2002,

NOTING that Rule 65 *bis* of the Rules of Procedure and Evidence of the International Tribunal ("Rules") provides that a Status Conference shall be convened within one hundred and twenty days of the last Status Conference, which, in these proceedings, occurred on 12 April 2002,

NOTING that the Trial Chamber is seised of an application filed by Sefer Halilović ("Accused") on 24 June 2002 pursuant to Article 13 of the Directive on Assignment of Defence Counsel issued by the International Tribunal for a review of the decision of the Registrar dated 19 June 2002 and that the application is pending,

CONSIDERING that it would be inappropriate to hold a Status Conference until the application has been determined,

CONSIDERING that, while the one hundred and twenty day period for holding a Status Conference will expire on 10 August 2002, as the Accused was granted provisional release on 13 December 2001, and is not in detention, he will not be unduly prejudiced by the holding of a Status Conference beyond that date,

PURSUANT to Rules 54 and 65 ter (B) of the Rules,

HEREBY POSTPONE the Status Conference to a time and date to be fixed.
