framework of a Status Conference, as from the day a decision on the Rule 98 bis motion has

been handed down,

**NOTING** that a Status Conference will be held in this case on 31 October 2002.

NOTING that the Pre-Defence conference, previously scheduled for 11 through

13 November 2002 has been rescheduled, and that this conference shall instead be held on

18 November from 9:00 - 10:30 hours in order to discuss the remaining issues only,

**HEREBY** attaches the revised schedule.
