I, O-Gon Kwon, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("International Tribunal");

**HAVING BEEN DESIGNATED** as the reviewing Judge by the President of the International Tribunal in an order filed confidentially and *ex parte* on 20 January 2003 pursuant to Rule 28 of the Rules of Procedure and Evidence of the International Tribunal ("Rules");

**BEING SEISED** of an indictment ("Indictment") and supporting material filed confidentially and *ex parte* on 15 January 2003 by the Office of the Prosecutor ("Prosecutor");

**BEING SEISED** of a motion filed confidentially and *ex parte* on 15 January 2003 by the Prosecutor requesting the reviewing Judge to issue a warrant for arrest and order for surrender of **VOJISLAV ŠEŠELJ**;

**BEING SEISED** of a corrigendum filed confidentially and *ex parte* on 29 January 2003 by the Prosecutor;

**FURTHER BEING SEISED** of additional material filed on 3 February and 5 February 2003 by the Prosecutor in relation to the Indictment;

**HAVING HEARD** the Prosecutor pursuant to Rule 47 of the Rules on 31 January 2003;

**CONSIDERING** on the basis of the material submitted by the Prosecutor that a *prima facie* case against **VOJISLAV ŠEŠELJ** in respect of the crimes with which he is charged in the Indictment has been established;

**PURSUANT** to Article 19 of the Statute of the International Tribunal and Rules 28, 47, 53 *bis*, 54, 55 and 59 *bis* of the Rules;

**HERBY CONFIRM** the Indictment in respect of each and every count therein, and

## **ORDER:**

Copies of the warrant for arrest and order for surrender shall be delivered by the Prosecutor to the authorities of Serbia and Montenegro and if necessary, to the competent authorities of any member State of the United Nations in whose territory or under whose jurisdiction **VOJISLAV ŠEŠELJ** is believed by the Prosecutor to be likely to be found.
