**TRIAL CHAMBER I** ("the Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("the Tribunal");

**NOTING** the arrest on 17<sup>th</sup> February 2003 of the accused, **Haradin BALA**, **Isak MUSLIU** and **Agim MURTEZI** and their subsequent transfer to the custody of the Tribunal on 18<sup>th</sup> February 2003;

**NOTING** the Decision of 18<sup>th</sup> February 2003 of this Chamber to vacate the order for non-disclosure of the indictment, entered on 27<sup>th</sup> January 2003;

**NOTING** the Order of the President of the Tribunal of 19<sup>th</sup> February 2003 to assign this case to Trial Chamber I;

**NOTING** the request of several press attachés for authorization to take photographs and to record the proceedings on video;

PURSUANT Rule 62 and Rule 81(D) of the Tribunal's Rules of Procedure and Evidence;

**HEREBY SCHEDULES** the initial appearance of the accused Haradin BALA, Isak MUSLIU and Agim MURTEZI for Thursday, 20<sup>th</sup> February 2003 at 14.15PM in Courtroom I;

AUTHORIZES, subject to any other Decision of the Trial Chamber or a Permanent Judge thereof,

- (1) the taking of still photographs by two designated press photographers at the commencement of the of all proceedings in this matter as directed by the Registrar of the Tribunal and, in particular, by the Chief of the Tribunal's Security Service; and
- (2) the release of the audio visual record of all proceedings in this matter as provided by the Registrar of the Tribunal.
