- (1) the taking of still photographs by four designated press photographers at the commencement of the all proceedings in this matter as directed by the Registrar of the Tribunal and, in particular, by the Chief of the Tribunal's Security Service; and
- (2) the release of the audio visual record of all open sessions in this case as provided by the Registrar of the Tribunal.
