I, Judge Hunt, Pre-Appeal Judge in this case,

NOTING the "Appellant and Respondent Dario Kordić's Notice to Appeals Chamber of his Decision not to Seek the Admission of 'Additional Evidence' under Rule 115 at this Time", filed confidentially on 7 April 2003 ("Kordić's Notice"), whereby Dario Kordić notified the Appeals Chamber that, with the possible exception of material from the testimony of General Blaškić and from the recent interview of Witness "AT", he elects not to seek the admission of additional evidence on appeal pursuant to Rule 115;¹

NOTING "Mario Čerkez's Motion to Admit Additional Evidence on Appeal Pursuant to Rule 115", filed on 7 April 2003 ("Čerkez's Rule 115 Motion");

NOTING "Mario Čerkez's Supplemental Application for Admittance of one Document as Additional Evidence on Appeal", filed on 9 April 2003 ("Supplemental Application"), whereby Mario Čerkez ("Čerkez") seeks leave to add one document, which he only received from the Prosecution on 3 April 2003, to his Rule 115 Motion;

NOTING "Mario Čerkez's Request to Add English Translation of one Document to Annex to Rule 115 Motion that was Filed on 7 April 2003", filed on 11 April 2003 ("Request"), whereby Čerkez seeks leave to add the English translation of one document to the annex of his Rule 115 Motion of 7 April 2003;

NOTING that the Prosecution informed the Appeals Chamber orally that it did not object to leave being granted in relation to either the additional document or the additional translation of one document;

NOTING that the Prosecution also informed the Appeals Chamber that it will need three weeks to respond to Čerkez's Rule 115 Motion and Supplemental Application and that it reserves its right to respond to the submissions made by Kordić in his Notice if and when he files a Rule 115 Motion;

HEREBY GRANT Čerkez leave to add the document contained in his Supplemental Application to his Rule 115 Motion and the document annexed to his Request to his Rule 115 Motion of 7 April
