TRIAL CHAMBER I ("Trial Chamber") of the International Tribunal for the Prosecution of

Persons Responsible for Serious Violations of International Humanitarian Law Committed in the

Territory of the Former Yugoslavia since 1991 ("Tribunal"),

NOTING the "Order of the President Assigning a Case to a Trial Chamber", issued by the

President of the Tribunal on 28 November 2002 assigning the case Prosecutor v. Momčilo Krajišnik

(Case No. IT-00-39) to Trial Chamber I under Rule 28(A) of the Rules of Procedure and Evidence

("the Rules");

NOTING that, pursuant to the Scheduling Order by Judge Alphons Orie of 11 March 2003, a

Status Conference was held on 14 March 2003 (the "Status Conference");

NOTING that, at the Status Conference, the commencement of the Trial was scheduled for 12 May

2003;

NOTING FURTHER that, at the Status Conference, a second Pre-Trial Conference was deemed

appropriate after the appointment of the ad litem judge to serve on the Bench for this case;

**CONSIDERING** that the date for the commencement of trial shall remain as scheduled,

**HEREBY ORDERS:** 

1. the Pre-Trial Conference shall be held on 9 May 2003 in Courtroom 2, commencing at

14:15, pursuant to Rule 73bis of the Rules;

2. the trial shall commence on 12 May 2003 at 9:00 in Courtroom 1;

3. the trial proceedings shall commence with the Opening Statement of the Prosecution,

pursuant to Rule 84 of the Rules;

4. the trial proceedings shall continue with the Opening Statement of the defence counsel for

the Accused, should the Defence elect to make its Opening Statement at this stage of the

proceedings as permitted in Rule 84 of the Rules;

5. the trial proceedings shall continue with a statement, under the control of the Trial Chamber,

by the Accused, should the Accused so wish to make a statement, as permitted by Rule 84

bis of the Rules,

6. the Prosecution shall immediately commence the presentation of evidence upon completion of the Opening Statements and statements by the Accused, if any, as indicated in Rule 85 of the Rules.
