TRIAL CHAMBER I, SECTION A, ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law

Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

BEING SEISED OF "Prosecution's Motion to Dismiss Charges Against Accused Momir Nikolić"

filed on 8 May 2003 ("Motion"), in which the Prosecutor moves to dismiss the remaining charges

against Momir Nikolić in the Amended Joinder Indictment dated 27 May 2002 ("Indictment"),

namely Genocide, Complicity in Genocide, Extermination as a Crime Against Humanity, Murder as

a Crime Against Humanity, Murder as a Violation of the Laws or Customs of War, and Inhumane

Acts (Forcible Transfer) as a Crime Against Humanity, in light of his plea of guilty to the charge of

Persecutions as a Crime Against Humanity in Count 5 of the Indictment,

NOTING the "Joint Motion for Consideration of Amended Plea Agreement between Momir

Nikolić and the Office of the Prosecutor" dated 7 May 2003 incorporating the Amended Plea

Agreement as Annex A, submitted to the Trial Chamber,

CONSIDERING that Momir Nikolić entered a plea of guilty to the charge of Persecutions as a

Crime Against Humanity in Count 5 of the Indictment at a public hearing held on 7 May 2003,

which was accepted by the Trial Chamber and a conviction rendered thereunder,

PURSUANT TO Rule 54 and Rule 62 ter of the Rules of Procedure and Evidence of the Tribunal,

HEREBY GRANTS the Motion.
