I, THEODOR MERON, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“International Tribunal”);

NOTING the “Appellant’s Brief on Appeal Against a Decision of the Trial Chamber Dated 9th October 2002” filed by counsel for Dragan Nikolić on 27 January 2003 (“Interlocutory Appeal”);

NOTING the order entitled “The President’s Assignment of Two Judges to the Appeals Chamber” issued on 4 June 2003 by the President of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens responsible for genocide and other such violations committed in the territory of neighbouring States, between 1 January and 31 December 1994”;

NOTING that Rule 27(C) of the Rules of Procedure and Evidence of the International Tribunal (“Rules”) provides that “The President may at any time temporarily assign a member of a Trial Chamber or of the Appeals Chamber to another Chamber”;

PURSUANT TO Rule 27(C) of the Rules of the International Tribunal;


