I, THEODOR MERON, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“International Tribunal”),

NOTING the “Request for the Counsel of Drago Josipović for the Prolongation of the Time Limit” filed by counsel for Drago Josipović on 30 May 2003;

NOTING that the Appeals Chamber’s decision on Josipović’s motion for review was issued on 7 March 2003 by a bench of the Appeals Chamber composed of Judge Pocar (Presiding), Judge Liu, Judge Güney, Judge Gunawardana and Judge Meron;¹

CONSIDERING the new composition of the Appeals Chamber of the International Tribunal set out in Document IT/215 of the International Tribunal (“Composition of the Appeals Chamber”), dated 13 June 2003 indicating, *inter alia*, that Judge Gunawardana is no longer a member of the Appeals Chamber;


HEREBY ASSIGN, with immediate effect, Judge Mohamed Shahabuddeen to this case;
