TRIAL CHAMBER I, SECTION A, ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

BEING SEISED OF the "Request for Reconsideration of the Decision of 1 July 2003, or Request for Leave to Appeal against that Decision, Related to the Motion by Independent Counsel in Relation to the Motion by Independent Counsel in Relation to the Response to Counsels and Co-Counsels and the Registrars Response to Independent Counsels Motion to Instruct the Registrar to Assign New Defence Counsel," filed on an ex parte and confidential basis on 3 July 2003 ("Request"),

NOTING that through the Request, the Independent Counsel assigned to assist the Accused Vidoje Blagojević on the issue of assignment of counsel requests that the Trial Chamber reconsider its decision of 1 July 2003,<sup>1</sup> in which it denied his motion for an extension of time to file a reply,<sup>2</sup> and in the event that it does not grant the extension of time, be granted leave to appeal the 1 July 2003 Decision,

NOTING that the underlying motion for which the reply was to be filed has already been ruled on by the Trial Chamber on 3 July 2003,3

CONSIDERING therefore that the Request is moot,

HEREBY DENIES the Request in full.
