I, THEODOR MERON, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("International Tribunal"),

NOTING the Notices of Appeal filed by Vinko Martinović and Mladen Naletilić on 29 April 2003, and the Prosecution's Notice of Appeal filed on 1 May 2003, against the Judgement rendered by Trial Chamber I on 31 March 2003;

CONSIDERING the composition of the Appeals Chamber of the International Tribunal set out in Document IT/215 of the International Tribunal for the former Yugoslavia ("Composition of the Appeals Chamber"), dated 13 June 2003;

PURSUANT TO Articles 12(3) and 14(3) of the Statute of the International Tribunal and Rule 27 of the Rules of Procedure and Evidence;


HEREBY ASSIGN, with immediate effect, Judges Wolfgang Schomburg and Inés Mónica Weinberg de Roca to replace Judges Claude Jorda and David Hunt in the present case;

AND DETERMINE that, in the case of *The Prosecutor v. Vinko Martinović, aka "Štela and Mladen Naletilić, aka "Tuta"*, Case No. IT-98-34-A, the Appeals Chamber shall now be composed, as follows:
