**ORDER TO LIFT NON-DISCLOSURE**

**The Office of the Prosecutor:**

**I, O-Gon Kwon**, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“International Tribunal”),

**HAVING BEEN DESIGNATED** as the reviewing Judge by the President of the International Tribunal in an order filed confidentially and *ex parte* on 26 September 2003 pursuant to Rule 28 of the Rules of Procedure and Evidence of the International Tribunal (“Rules”) for review of the indictment against Nebojša PAVKOVIĆ, Vladimir LAZAREVIĆ, Vlastimir ĐORĐEVIĆ, and Sreten LUKIĆ (collectively, “Accused”) submitted by Office of the Prosecutor (“Prosecution”),

**NOTING** the confirmation of the indictment against the Accused (“Indictment”) and the issuance of the arrest warrants against each Accused (“Arrest Warrants”) on 2 October 2003,

**NOTING** the “Order for Delay in Publication of Indictment” issued confidentially and *ex parte* on 2 October 2003, ordering the delay in disclosure of the Indictment and Arrest Warrants until a period ending at 09:00 hours (The Hague Time) on Monday, 6 October 2003, unless otherwise ordered,

**NOTING** the “Second Order for Delay in Publication of Indictment” issued confidentially and *ex parte* on 6 October 2003, ordering the further delay in disclosure of the Indictment and Arrest Warrants until a period ending at 16:00 hours (The Hague Time) on Thursday, 23 October 2003, unless otherwise ordered,


**BEING SEISED** of the “Motion to Lift Order on Non-Disclosure” filed confidentially and *ex parte* on 9 October 2003 (“Motion”) by the Prosecution, requesting the reviewing Judge to lift the non-disclosure order of the Indictment and Arrest Warrants,

**CONSIDERING** various factors surrounding this case at hand,

**PURSUANT TO** Rules 53 and 54 of the Rules,

**HEREBY ORDER** the lifting of the non-disclosure order of the Indictment and Arrest Warrants with immediate effect.
