I, AMIN EL MAHDI, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (the "Tribunal");

**NOTING** the Presiding Judge's Order of 23<sup>rd</sup> July 2002 under Rule 65<sup>ter</sup>(A) of the Rules of Procedure and Evidence ("the Rules") to designate me as the Pre-Trial Judge in the case *The Prosecutor v. Radovan Stanković* ("the Accused"), case number IT-96-23/2-PT;

**NOTING** further that the Defence Counsel assigned to the Accused was unable to attend a Status Conference in The Hague before 20<sup>th</sup> November 2003;


**PURSUANT** to Rule 65<sup>bis</sup>(A) of the Rules;
