TRIAL CHAMBER I, ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("the Tribunal");

NOTING the finding of guilt entered against Miodrag Jokić by the Trial Chamber on 27th August 2003, based on his plea of guilty to all Counts contained in the Second Amended Indictment dated 27th August 2003 ("the 2nd Amended Indictment");

NOTING the Sentencing Briefs filed by the Parties on 14th November 2003;

PURSUANT TO Rule 54 and Rule 100 of the Rules;

HEREBY SUSPENDS the Order of 20th February 2002 on the Provisional Release of Miodrag Jokić from Tuesday, 2nd December 2003 until further notice by the Trial Chamber; and

ORDERS Miodrag Jokić to return to the United Nations Detention Unit on Tuesday, 2nd December 2003; and

REQUESTS the Government of Serbia and Montenegro to assign and instruct an official to escort Mr. Miodrag Jokić on Tuesday, 2nd. December 2003 on his return flight to an airport in the Kingdom of The Netherlands, and to hand him over to the Dutch Authorities at that Airport for the Dutch Authorities to bring him back to the United Nations Detention Unit; and

SCHEDULES the Sentencing Hearing for 4th December 2003, from 9:00 AM in a Courtroom to be announced by the Registrar.
