I, Joaquín Martín Canivell, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (the "Tribunal");

**NOTING** the Presiding Judge's Order of 23 May 2003 under Rule 65ter(A) of the Rules of Procedure and Evidence ("the Rules") designating me as the Pre-Trial Judge in the case *The Prosecutor* v. *Fatmir LIMAJ, Haradin BALA, Isak MUSLIU* (IT-03-66-PT);

**NOTING** that the last Status Conference under Rule 65*bis* of the Rules of Procedure and Evidence of the Tribunal (the "Rules") was held on 23 October 2003;

**RECALLING** the Decision on Prosecution's Motion to Amend the Amended Indictment filed by Trial Chamber I of the Tribunal on 9 February 2004, ordering that (i) the Accused Fatmir Limaj, Haradin Bala and Isak Musliu enter a plea to the charges under Count 5 of the second Amended Indictment, and to the new allegation of Joint Criminal Enterprise liability and that (ii) the Accused Isak Musliu enter a plea to the new allegation of command responsibility at a hearing to be held on 27 February 2004;

**CONSIDERING** that it is in the interests of justice and of the fair and expeditious conduct of the proceedings to hold the Status Conference and the further Initial Appearance on the same date;

PURSUANT to Rules 50 (B), 65bis and 65ter of the Rules;

**HEREBY ORDERS** that a further Initial Appearance of the Accused pursuant to Rule 50(B), followed by a Status Conference pursuant to Rule 65*bis*, be held on Friday, 27 February 2004 at 14:30 hours in Courtroom I in the presence of the Accused and his Defence Counsel.
