NOTING the scheduling order orally rendered on 27 February 2004;

PURSUANT TO Articles 20 and 21 of the Statute, and Rule 54 of the Rules;

#### HEREBY CONFIRMS THE ORAL ORDER:

- 1. With respect to a possible motion for judgement of acquittal pursuant to Rule 98 bis:
  - a. Vidoje Blagojević and Dragan Jokić shall each file a motion for entry of judgement of acquittal pursuant to Rule 98 bis, if any, by no later than 2 March 2004;
  - b. The Prosecution shall file its response to any such motions by no later than 12 March 2004;

### 2. With respect to the Defence cases:

- a. Vidoje Blagojević and Dragan Jokić shall file preliminary witness and exhibits lists pursuant to Rule 65 ter (G) by 18 March 2004;
- b. Pursuant to Rule 73 ter, a Pre-Defence Conference shall be held on 5 April 2004;
- vidoje Blagojević's presentation of evidence shall commence on Tuesday, 6 April
  2004, if necessary following the Trial Chamber's judgement pursuant to Rule 98 bis.
