TRIAL CHAMBER I ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("the Tribunal");

NOTING that a finding of guilt was entered by the Trial Chamber on 27 August 2003 against Miodrag Jokić after he pleaded guilty on all counts of the Second Amended Indictment;

NOTING that a Sentencing Hearing was held on 4 December 2003;

RECALLING its Order on Miodrag Jokić's Request for Continued Provisional Release of 4 December 2003, in which the Trial Chamber ordered, *inter alia*, that "[t]he period of further provisional release [...] shall end on a date to be set by the Scheduling Order for the Sentencing Judgement";

PURSUANT TO Rules 73 and 100 of the Rules of Procedure and Evidence;

HEREBY ORDERS that

- (i) the Order on Miodrag Jokić's Request for Continued Provisional Release of 4 December 2003 be vacated on Tuesday, 16 March 2004;
- (ii) Miodrag Jokić return to the Tribunal on Tuesday, 16 March 2004;
- (iii) Miodrag Jokić be taken into custody at the United Nations Detention Unit ("UNDU");
- (iv) the Registrar take all the necessary steps to facilitate the Miodrag Jokić's return to the Tribunal and to ensure his custody at the UNDU;

REQUESTS the Government of Serbia and Montenegro to ensure that a designated official accompanies Miodrag Jokić on his return flight to the Kingdom of the Netherlands and hands him over to the Dutch Authorities upon the arrival of his flight in The Netherlands on Tuesday, 16 March 2004.

SCHEDULES the pronouncement of the sentencing judgement in this case to take place on 18 March 2004 at 3 p.m. in Courtroom III, in the presence of Miodrag Jokić, his Defence Counsel and the Prosecutor.
