# FURTHER SCHEDULING ORDER ON COMMENCEMENT OF DEFENCE CASE

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("the International Tribunal"),

**NOTING** the Trial Chamber's "Order on Future Conduct of the Trial", issued 6 July 2004, wherein the Trial Chamber ordered, *inter alia*, the following:

- (1) The trial is adjourned until Wednesday, 14 July 2004, at which time, subject to the medical condition of the Accused, it will recommence; and
- (2) The trial will thereafter be adjourned on Wednesday, 21 July 2004 until Tuesday, 31 August 2004, thereby allowing the Accused additional time in which to prepare for the presentation of his case,

**NOTING** the "Scheduling Order and Order to Registrar Concerning Medical Report", issued on 12 July 2004, in which the Trial Chamber (1) adjourned the trial on the basis of a medical report of Dr. M.I. Sedney, dated 12 July 2004, in which, on the basis of the blood pressure values of the Accused, she advised that the Accused should rest, and (2) further ordered as follows:

- (1) The Registrar shall obtain a report from the treating cardiologist by the end of Friday, 16 July 2004 indicating whether the Accused is fit to participate in court proceedings from Monday, 19 July 2004 to Wednesday, 21 July 2004; and
- (2) The trial is adjourned to Monday, 19 July 2004, pending the above-referenced report,

**CONSIDERING** the medical report of Dr. M.I. Sedney, dated 16 July 2004, in which, on the basis of the blood pressure values of the Accused, she advises that he should not attend the hearing set for Monday, 19 July 2004,

**PURSUANT TO** Articles 20 and 21 of the Statute of the International Tribunal and Rule 54 of the Rules of Procedure and Evidence of the International Tribunal,

**HEREBY ORDERS** that the trial is adjourned to Tuesday, 31 August 2004.
