TRIAL CHAMBER II ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

BEING SEISED OF the "Notice By Amicus Curiae Prosecutor of Intent to Provide the Office of the Prosecutor with Legal Arguments, Conclusions of Law and Authority contained in Confidential Filings", filed on 14 July 2004, in which the amicus curiae Prosecutor provides notice to the Trial Chamber of her intent to provide the Office of the Prosecutor by 19 July 2004 with legal arguments, conclusions of law, and authorities cited in confidential pleading and decisions in the instant case, arguing that this material is of consequence to the Office of the Prosecutor in other cases and, possibly, in further proceedings in the Brāanin case;

NOTING the "Order to *Amicus Curiae* Prosecutor" of 16 July 2004, in which the Trial Chamber ordered the *amicus curiae* Prosecutor not to disclose any confidential material from the instant case to the Office of the Prosecutor until further notice;

NOTING the "Clarification of Notice by *Amicus Curiae* Prosecutor of intent to Provide the Office of the Prosecutor with Legal Arguments, Conclusions of Law and Authority contained in Confidential Filings", filed on 21 July 2004, in which the *amicus curiae* Prosecutor identifies the relevant material it intends to disclose;

CONSIDERING that the Trial Chamber is now satisfied that the *amicus curiae* Prosecutor intends to disclose exclusively non-confidential legal material;

CONSIDERING that the Respondent does not object to the disclosure of the said material;

FOR THE FOREGOING REASONS

PURSUANT to Rules 54 and 73 of the Rules of Procedure and Evidence

PERMITS the *amicus curiae* Prosecutor to disclose the confidential material from the instant case to the Office of the Prosecutor as identified.
