HAVING BEEN APPOINTED as pre-trial Judge in this case by virtue of an Order of Trial Chamber III dated 10 December 2001,

NOTING the statement of the Office of the Prosecutor ("Prosecution") at the status conference held on 9 September 2004 that, in view of the length of time that has passed since the filing of the Prosecution pretrial brief on 17 June 2002, the Prosecution is considering the possibility of seeking leave of the Trial Chamber to submit a revised pre-trial brief,

CONSIDERING that this case is expected to be set down for trial before the end of this year and that it would be in the interests of a fair and expeditious trial for revised pre-trial briefs, if there are to be any, to be submitted as soon as possible,

PURSUANT to Rule 65 bis (E) of the Rules of Procedure and Evidence of the International Tribunal,

HEREBY ORDER the parties to file final pre-trial briefs in accordance with the following schedule:

- (1) the Prosecution shall file its final pre-trial brief no later than Wednesday 13 October 2004 or shall indicate to the Trial Chamber by that date that the pre-trial brief as filed on 17 June 2002 shall stand as the final Prosecution pre-trial brief in this matter; and
- (2) the Defence shall file its final pre-trial brief no later than Monday 1 November 2004 or shall indicate to the Trial Chamber by that date that the pre-trial brief as filed on 26 March 2003¹ shall stand as the final Defence pre-trial brief in this matter.
