**I, THEODOR MERON,** President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia Since 1991 ("Tribunal"),

**NOTING** that Rule 73(B) permits a Trial Chamber to certify an interlocutory appeal of a decision if the decision involves "an issue that would significantly affect the fair and expeditious conduct of the proceedings or the outcome of the trial";

**NOTING** that on 27 July 2004, Trial Chamber I issued a "Certification for Appeal of Decision on Defence's Motion for Review of Registrar's Decision not to Rank the Case to Level III Complexity";

**CONSIDERING** the composition of the Appeals Chamber of the Tribunal as set out in Document IT/222, dated 17 November 2003;

**CONSIDERING** Articles 12(3) and 14(3) of the Statute of the Tribunal, and Rule 27(C) of the Rules of Procedure and Evidence of the International Tribunal;

**NOTING** Article 14(2) of the Statute of the Tribunal, which provides that the President of the Tribunal is *ex officio* the Presiding Judge of the Appeals Chamber;

**HEREBY ORDER** that in *Milan Martić v. The Prosecutor*, Case No. IT-95-11-AR73.1, the Appeals Chamber shall be composed, with immediate effect, as follows:
