I, AMIN EL MAHDI, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia Since 1991,

NOTING the Decision to Confirm the Indictment against Miroslav Bravo (“the Accused”) issued by Judge McDonald on 10 November 1995;

NOTING the Warrant of Arrest and Order for Surrender, issued *ex parte* and under seal on 29 January 2003;

NOTING that the Accused surrendered himself voluntarily to the SFOR in the village of Medjugorje in Bosnia and Herzegovina on Wednesday, 10 November 2004 and was subsequently transferred to the custody of the Tribunal on Friday, 12 November 2004;

NOTING the President’s Order of 11 November 2004 to assign the case to Trial Chamber I as of the date of transfer of the Accused to the seat of the Tribunal;

NOTING that the initial appearance of the Accused was held before myself on 15 November 2004 and that the Accused reserved his right to enter a plea within thirty days pursuant to Rule 62 (iii) of the Rules of Procedure and Evidence;

NOTING the Order of 19 November 2004 designated Judge Liu Daqun as Pre-Trial Judge in this case;

NOTING that I have been requested by Judge Liu to proceed with the further appearance of the Accused since the Accused initially appeared before me on 15 November 2004;


NOTING that the delay of 30 days is expiring and that it is necessary to schedule a new hearing for the Accused to enter a plea;
