HAVING ISSUED a "Decision on Review of Indictment" on 9 March 2005, confirming the Indictment, issuing arrest warrants and further ordering that there be no public disclosure of the Indictment, supporting materials, or Arrest Warrants until further order,

BEING SEISED OF a confidential and ex parte "Prosecution's Motion to Lift the Non-Disclosure Order of the Indictment, Arrest Warrants and Indictment Confirmation Decision", filed on 15 March 2005 ("Motion"), in which the Prosecution seeks an order making public the Indictment, arrest warrants and confirmation decision, but maintaining the confidentiality of the supporting material to the Indictment.

CONSIDERING that it is in the interests of justice to grant the Motion,

PURSUANT TO Article 19 of the Statute of the International Tribunal and Rules 47, 52, 53, and 54 of the Rules of Procedure and Evidence of the International Tribunal,

HEREBY GRANT the relief sought in the Motion and ORDERS the Registrar to forthwith change the status of the decision of confirmation, the indictment and the arrest warrants issued by me in respect of this matter to public filings.
