I, Carmel Agius, Presiding Judge of Trial Chamber II of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

NOTING the Indictment in case *The Prosecutor v. Ramush Haradinaj, Idriz Balaj and Lahi Brahimaj* dated 25 February 2005;

NOTING the Order issued by the Vice-President of the Tribunal of 9 March 2005, assigning the case to Trial Chamber II;

NOTING that the initial appearance of the accused Ramush Haradinaj, Idriz Balaj and Lahi Brahimaj pursuant to Rule 62(iii) of the Tribunal’s Rules of Evidence and Procedure (“Rules”) took place before me on 14 March 2005;

NOTING Rule 65ter of the Rules which provides that the Presiding Judge of the Trial Chamber shall “designate from among its permanent members a Judge responsible for the pre-trial proceedings” (“pre-trial Judge”);

NOTING Article 13quarter of the Statute of the Tribunal (“Statute”), enabling *ad litem* Judges of the Tribunal to adjudicate in pre-trial proceedings;

NOTING the powers of a pre-trial Judge as set out in Rule 65ter of the Rules;

PURSUANT TO Article 13quarter of the Statute and Rule 65ter of the Rules;

HEREBY DESIGNATE as follows:


1. The Trial Chamber seised of the case shall be composed of:
