I, Carmel Agius, Presiding Judge of Trial Chamber II of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

NOTING the Indictment in the case *The Prosecutor v. Mićo Stanišić* confirmed by Judge Amin El Mahdi on 25 February 2005;

NOTING the Order issued by the President of the Tribunal dated 11 March 2005, assigning the case against Mićo Stanišić to Trial Chamber II;

NOTING that the initial appearance of the accused Mićo Stanišić pursuant to Rule 62 of the Rules of Procedure and Evidence of the Tribunal (“Rules”) took place before me on 17 March 2005;

CONSIDERING Article 13*quater*(1)(d) of the Statute of the Tribunal (“Statute”) enabling *ad litem* Judges of the Tribunal to adjudicate in pre-trial proceedings;

CONSIDERING Rule 65*ter*(A) of the Rules providing that the Presiding Judge of the Trial Chamber shall “designate from among its members a Judge responsible for the pre-trial proceedings” (“pre-trial Judge”);

NOTING the powers of a pre-trial Judge as set out in Rule 65*ter* of the Rules;

PURSUANT TO Article 13*quater* of the Statute and Rule 65*ter* of the Rules;

HEREBY ORDER that Trial Chamber II in the case *The Prosecutor v. Mićo Stanišić* shall be composed as follows:

Judge Krister Thelin
Judge Christine Van Den Wyngaert;

AND DESIGNATE:


Judge Krister Thelin as pre-trial Judge for this case.
