**I, IAIN BONOMY,** Judge of Trial Chamber III of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("International Tribunal"),

**HAVING BEEN DESIGNATED** as pre-trial Judge in this matter by virtue of an Order of 7 March 2005,

**NOTING** the "Order Scheduling Status Conference", dated 12 April 2005 ("scheduling order"), scheduling a status conference for the accused Vladimir Lazarević and Sreten Lukić on 13 May 2005 at 3.30pm,

**HEREBY ORDER** that the status conference will proceed on 13 May 2005 but only in respect of the accused Lazarević.
