TRIAL CHAMBER II ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

BEING SEISED OF the "Defence Motion on Behalf of Ramush Haradinaj for Provisional Release" ("Motion"), filed by counsel for Ramush Haradinaj ("Defence") on 21 April 2005;

NOTING the "Prosecution's Response to Defence Motion on Behalf of Ramush Haradinaj for Provisional Release" ("Response"), filed on 5 May 2005;

FURTHER NOTING the "Defence's Reply to 'Prosecution's Response to Defence Motion on Behalf of Ramush Haradinaj for Provisional Release'", filed on 12 May 2005, in which the Defence seeks leave to reply to the Response;

ALSO NOTING a submission made by the United Nations Mission ("UNMIK") to Kosovo for consideration of the Trial Chamber, received on 17 May 2005;

CONSIDERING that according to Rule 126bis of the Tribunal's Rules of Procedure and Evidence ("Rules"), a Trial Chamber may grant leave for a party to file a response;

CONSIDERING that according to Rule 65(B) of the Rules, the provisional release of an accused may only be ordered by a Trial Chamber after giving the host country and the State to which the accused seeks to be released the opportunity to be heard and only if the Trial Chamber is satisfied that the accused will appear for trial and, if released, will not pose a danger to any victim, witness or other person;

CONSIDERING that Ramush Haradinaj seeks to be provisionally released to Kosova/Kosovo, a territory in which UNMIK is the authority entrusted with ensuring public safety and conducting border monitoring, and therefore, as the guarantor of public safety and order, the appropriate authority to provide the Tribunal with any guarantees that the Accused will not flee and that if he does so, he will be arrested;¹

CONSIDERING the submissions made in the Motion, the Response and the Reply, and the submission by UNMIK;

FINDING that it is necessary to hold a hearing prior to taking a decision on the Motion;

PURSUANT TO Rules 54, 65 and 126bis of the Rules

HEREBY GRANTS LEAVE to the Defence to file its Reply;

ORDERS

that the Motion for Provisional Release shall be addressed in the presence of Ramush Haradinaj at a hearing to be held on Tuesday, 24 May 2005, at 14:30 hours, in Courtroom III of the Tribunal, at

which each of the parties will be allowed fifteen minutes of time to present their submissions;

INVITES

1) an authorised representative of UNMIK to appear at that hearing to explain the guarantees

UNMIK is able and willing to give in relation to the Motion for Provisional Release, within five

minutes of time;

2) an authorised representative of the Government of the Kingdom of the Netherlands to

appear at that hearing to explain the host country's position vis-à-vis the Motion for Provisional

Release, within five minutes of time; and

REQUESTS

the Registrar to communicate this Order to UNMIK and to the Government of the Kingdom of the

Netherlands.
