THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("the International Tribunal"),

BEING SEISED of a confidential "Motion for Provisional Release" filed by the Defence for the accused Nebojša Pavković ("the Defence") on 10 June 2005 ("Motion"), in which it argues that the Accused meets the criteria established in Rule 65(B), and that the individual circumstances of his case support a grant of provisional release,

CONSIDERING that Rule 65(B) ("Provisional Release") of the Rules of Procedure and Evidence of the International Tribunal ("Rules") requires an applicant for provisional release to satisfy the Trial Chamber of two matters: (1) that he will appear for trial, and (2) that, if released, he will not pose a danger to any victim, witness or other person,¹

NOTING the Defence submission that the "[it] would be prepared to provide further arguments and evidence during an oral hearing" in support of the Motion,²

CONSIDERING that the Trial Chamber may be assisted by further submissions on the first prong of the inquiry, that is, the likelihood that the Accused will return for trial, if released, in particular, on the circumstances of his surrender,

NOTING the Prosecution's submission that "should the Trial Chamber be inclined to rely on any of the guarantees produced, an official from each guaranteeing body should be examined by the Trial Chamber about their obligations and undertakings",³

CONSIDERING that the Prosecution has identified no particular features of this application that would warrant an examination of representatives of the Government of Serbia and Montenegro and the Republic of Serbia with regard to the guarantees offered,
