**CONSIDERING** Articles 12(3) and 14(3) of the Statute of the Tribunal and Rules 27 of the Rules of Procedure and Evidence;


**CONSIDERING** the composition of the Appeals Chamber of the Tribunal as set out in Document IT/237Rev.1, issued on 22 July 2005;
