**HAVING BEEN DESIGNATED** Pre-Trial Judge with regard to:

1. *The Prosecutor v Mile Mrkšić* by the “Order Appointing a Pre-Trial Judge” issued by Trial Chamber II of the Tribunal on 16 May 2002;
2. *The Prosecutor v Miroslav Radić* by the “Order Appointing a Pre-Trial Judge” issued by Trial Chamber II on 20 May 2003; and
3. *The Prosecutor v Veselin Šljivančanin* by the “Order Appointing a Pre-Trial Judge” issued by Trial Chamber II on 2 July 2003;

**CONSIDERING** that the last Status Conference for all three Accused was held on Thursday 12 May 2005;

**NOTING** the Scheduling Order of 20 July 2005 according to which a Status Conference for Mile Mrkšić, Miroslav Radić and Veselin Šljivančanin shall be held at 14.30 on Thursday, 8 September 2005 in Courtroom I;

**NOTING**, however, the discussions held between the parties in the course of the meeting convened pursuant to Rule 65ter of the Rules of Procedure and Evidence (“Rules”) on Wednesday, 24 August 2005 and having regard to a change in the date of the Status Conference;


**FOR THE FOREGOING REASONS**
