I, Hans Henrik Brydensholt, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

**NOTING** the "Defence Motion on Behalf of Lahi Brahimaj for Provisional Release" ("Motion"), filed confidentially by counsel for Lahi Brahimaj ("Defence" and "Accused") on 16 September 2005; in which the Defence expects that the United Nations Interim Administration Mission in Kosovo ("UNMIK") will shortly express its views on the Motion, including any guarantees and undertakings UNMIK might be willing to offer;<sup>1</sup>

**NOTING** that the Defence will present to the Trial Chamber further references attesting to the personal and professional integrity of the Accused;<sup>2</sup>

**CONSIDERING** that it would be appropriate to expedite proceedings by setting time-limits for the various anticipated filings;

PURSUANT TO Rules 54, 65, 65ter, 126bis and 127 of the Tribunal's Rules of Procedure and Evidence

## **HEREBY DISPOSE AS FOLLOWS:**

1. UNMIK is requested to provide the Trial Chamber with an assessment regarding the Motion, including possible guarantees and undertakings, no later than by 3 October 2005;

2. The Defence shall submit any further references attesting to the personal and professional integrity of the Accused no later than by 3 October 2005;

3. The Office of the Prosecutor shall file a response to the Motion, if any, no later than by 10 October 2005;

4. The Registrar of the Tribunal shall communicate this Order to UNMIK, as well as the Defence Motion of 16 September 2005, as soon as practicable.
