CONSIDERING the “Order Replacing a Judge in a Case before the Appeals Chamber”, filed on 15 July 2005, in *Prosecutor v. Niyitegeka*, Case No. ICTR-96-14-A;

PURSUANT TO Articles 12(3) and 14(3) of the Statute of the International Tribunal and Rule 27 of the Rules;


HEREBY ASSIGN, with immediate effect, Judge Andréia Vaz to replace Judge Inés Mónica Weinberg de Roca in the present case;
