**I, Carmel Agius,** Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("International Tribunal");

**NOTING** the "Decision on Prosecution's Motion for Leave to Amend the Indictment", issued on 2 June 2005 (dated 27 May 2005) ("Decision") where the Trial Chamber decided that the Prosecution's proposed Amended Indictment shall be the operative indictment against the Accused Vojislav Šešelj ("Accused") subject to a minor clarification, and ordered that a further appearance shall be held as soon as practicable to enable the Accused to enter a plea on new charges in the operative indictment;

**NOTING** that the Prosecution filed the Modified Amended Indictment on 15 July 2005 incorporating the ordered clarification;

**NOTING** Rule 50(B) of the Rules and Procedure of Evidence ("Rules") which provides that "[i]f the amended indictment includes new charges and the accused has already appeared before a Trial Chamber in accordance with Rule 62, a further appearance shall be held as soon as practicable to enable the accused to enter a plea on the new charges";

CONSIDERING that the Modified Amended Indictment includes new charges;

**NOTING** that the Accused has pleaded pursuant Rule 62 of the Rules on 26 February 2003 and 25 March 2003;

**NOTING** that the further appearance on 3 October 2005 the Accused chose not to enter a plea in relation to the new charges in the Modified Amended Indictment;

**HEREBY SCHEDULES** a further appearance of the Accused for Thursday, 3 November 2005, commencing at 8.00, during which the Accused, pursuant to Rule 50(B) of the Rules, will enter a plea in relation to new charges in the Modified Amended Indictment.
