I, Carmel Agius, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

HAVING DESIGNATED MYSELF pre-trial Judge in the case of *Prosecutor v. Vujadin Popović*, Ljubiša Beara, Drago Nikolić, Ljubomir Borovčanin, Zdravko Tolimir, Radivoje Miletić, Milan Gvero, Vinko Pandurević and Milorad Trbić, Case No. IT-05-88-PT;<sup>1</sup>

**NOTING** the "Decision on Motion for Joinder" of 21 September 2005 in which Trial Chamber III granted the motion which the Office of the Prosecutor ("Prosecution") filed on 10 June 2005, seeking to join the cases of *Prosecutor v. Vujadin Popović*<sup>2</sup>, *Prosecutor v. Ljubiša Beara*<sup>3</sup>, *Prosecutor v. Drago Nikolić*<sup>4</sup>, *Prosecutor v. Ljubomir Borovčanin*<sup>5</sup>, *Prosecutor v. Zdravko Tolimir*, *Radivoje Miletić and Milan Gvero*<sup>6</sup>, *Prosecutor v. Vinko Pandurević and Milorad Trbić*<sup>7</sup> ("Joinder Motion");

**NOTING** the "Order Assigning a Case to a Trial Chamber" issued by the President of the Tribunal on 26 September 2005, assigning the case of *Prosecutor v. Vujadin Popović*, *Ljubiša Beara*, *Drago Nikolić*, *Ljubomir Borovčanin*, *Zdravko Tolimir*, *Radivoje Miletić*, *Milan Gvero*, *Vinko Pandurević and Milorad Trbić*, Case No. IT-05-88-PT, to Trial Chamber II;

**NOTING** Rule 65bis of the Rules of Procedure and Evidence of the Tribunal ("Rules") which provides, *inter alia*, that a status conference shall be convened within one hundred and twenty days after the last status conference to i) organise exchanges between the parties so as to ensure expeditious preparation for trial; and ii) to review the status of his or her case and to allow the accused the opportunity to raise issues in relation thereto, including the mental and physical condition of the accused;

**NOTING** that the last Status Conferences for each of the eight Accused transferred to the Tribunal<sup>8</sup> were held respectively on

- i) 22 July 2005 for Vujadin Popović;
- ii) 15 June 2005 for Ljubiša Beara;

- iii) 24 August 2005 for Drago Nikolić;
- iv) 24 August 2005 for Ljubomir Borovčanin;
- v) 28 June 2005 for Radivoje Miletić and Milan Gvero;
- vi) 24 August 2005 for Vinko Pandurević and Milorad Trbić;

**NOTING** further that the next Status Conferences for Vujadin Popović and Ljubiša Beara scheduled for 21 September 2005<sup>9</sup> were not held in light of the then pending Joinder Motion;

CONSIDERING that, in light of the specific circumstances of this case arising from the Joinder Motion, the fact that the last Status Conferences for Vujadin Popović and Ljubiša Beara were held more than 120 days prior to the Status Conference provided for in this Scheduling Order, does not prejudice the rights of the two Accused, Vujadin Popović and Ljubiša Beara;

**NOTING** in addition the "Decision concerning motion for provisional release of Radivoje Miletić" rendered by Trial Chamber II on 19 July 2005, the "Decision concerning motion for provisional release of Milan Gvero" also rendered by Trial Chamber II on 19 July 2005 and the "Decision on interlocutory appeal against Trial Chamber's decision granting provisional release" issued by the Appeals Chamber on 19 October 2005, pursuant to which Radivoje Miletić and Milan Gvero are currently on provisional release;

**NOTING** the "Prosecution's Motion for Amendments to the Indictments" filed by the Prosecution on 28 June 2005, in which the Prosecution seeks to add a number of charges against some of the Accused in this case, namely

- i) for Zdravko Tolimir: Count 1 (Genocide), Count 2 (Conspiracy to commit genocide) and Count 3 (Extermination as a crime against humanity) all pursuant to Article 7(1) of the Statute of the Tribunal ("Statute");
- ii) for Vujadin Popović: Count 2 (Conspiracy to commit genocide) pursuant to Article 7(1) of the Statute of the Tribunal ("Statute");
- iii) for Drago Nikolić: Count 2 (Conspiracy to commit genocide) pursuant to Article 7(1) of the Statute;

- iv) for Milorad Trbić: Count 1 (Genocide), Count 2 (Conspiracy to commit genocide) and Count 3 (Extermination as a crime against humanity) all pursuant to Article 7(1) of the Statute; and
- v) for Vujadin Popović, Ljubiša Beara, Drago Nikolić, Ljubomir Borovčanin, Vinko Pandurević and Milorad Trbić: Count 6 (Persecutions, including forcible transfer, as a crime against humanity), Count 7 (Inhumane Acts (forcible transfer) as a crime against humanity) and Count 8 (Deportation as a crime against humanity) are amended to include the Bosnian Muslim population of Žepa;

**NOTING** Rule 50(B) of the Rules which provides that, if the amended indictment includes new charges and the accused has already appeared before a Trial Chamber, a further appearance shall be held as soon as practicable to enable the accused to enter a plea on the new charges;

### **PURSUANT TO** Rules 50 and 65bis of the Rules;

#### HEREBY ORDER

- i) that a Status Conference for the Accused Vujadin Popović, Ljubiša Beara, Drago Nikolić, Ljubomir Borovčanin, Radivoje Miletić, Milan Gvero, Vinko Pandurević and Milorad Trbić shall be held on Thursday 10 November 2005 at 14.15 in Courtroom III; and that
- ii) during the course of the Status Conference, the Accused Vujadin Popović, Ljubiša Beara, Drago Nikolić, Ljubomir Borovčanin, Vinko Pandurević and Milorad Trbić shall enter pleas of guilty or not guilty on the new charges sought to be included by the Prosecution in the Consolidated Amended Indictment, namely
  - for Vujadin Popović: Count 2 (Conspiracy to commit genocide) pursuant to Article 7(1) of the Statute of the Tribunal ("Statute");
  - for Drago Nikolić: Count 2 (Conspiracy to commit genocide) pursuant to Article 7(1) of the Statute;
  - for Milorad Trbić: Count 1 (Genocide), Count 2 (Conspiracy to commit genocide) and Count 3 (Extermination as a crime against humanity) all pursuant to Article 7(1) of the Statute; and

for Vujadin Popović, Ljubiša Beara, Drago Nikolić, Ljubomir Borovčanin, Vinko Pandurević and Milorad Trbić: Count 6 (Persecutions, including forcible transfer, as a crime against humanity), Count 7 (Inhumane Acts (forcible transfer) as a crime against humanity) and Count 8 (Deportation as a crime against humanity) as amended to include the Bosnian Muslim population of Žepa.
