**I, KEVIN PARKER,** Acting President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia Since 1991 ("Tribunal"),

**NOTING** the Indictment in the *Prosecutor v. Ante Gotovina*, Case No. IT-01-45, filed on 31 May 2001;

NOTING the Amended Indictment in this case, filed on 19 February 2004;

**NOTING** that the Registry has advised that Ante Gotovina ("Accused") has been detained and will be transferred to the seat of the Tribunal pursuant to Rule 62 of the Rules of Procedure and Evidence ("Rules") during the month of December 2005;

**NOTING** that Rule 62 requires the President of the Tribunal forthwith assign the case to a Trial Chamber upon the transfer of the Accused to the seat of the Tribunal;

NOTING that President Pocar is currently absent from the Tribunal on official Tribunal business;

**NOTING** that Rule 21 provides that the Vice-President shall exercise the functions of the President in case of the latter's absence or inability to act;

CONSIDERING the trial management and case distribution needs of the Tribunal;

**CONSIDERING** the composition of the Trial Chamber of the Tribunal as set out in document IT/242 issued on 17 November 2005;

**HEREBY ASSIGN**, effective on the date upon which the Accused is transferred to the seat of the Tribunal, the present case to Trial Chamber II;

**AND ORDER** that the Trial Chamber shall, for the purposes of the present case, be composed as follows:
